From The Lawyer's Desk

One of the benefits of JFT membership is your access to a wealth of information about a variety of issues. For example, we advise members to call the union (and check school board policy) before you do something on your own, such as:

- **Before** you discipline a student...to find out what you are allowed to do, and what you are prohibited from doing. Are you allowed to use corporal punishment, are you allowed to require a student to write lines, etc.;
- **Before** you physically break up a fight, to find out what the policy *requires*, what the policy *allows*, and what the policy *prohibits*;
- **Before** you wear a political button or clothing that expresses an opinion;
- **Before** you videotape or take any pictures of students;
- **Before** you blog, tweet, or post pictures or anything

else on Facebook, Instagram, or any social media, that is related to your job or that might impact your employment;

- **Before** you drive a student in your personal vehicle;
- **Before** you act on your own when you have cause to suspect that a child has been abused or neglected.
- Or anything else...

The JFT will advise you of your rights and your responsibilities. The staff will help you try to avoid areas that cause employment problems. But remember...this service is available **ONLY** to JFT members.

Tell Lawmakers to Make Smart Choices for Louisiana

Our state is facing a mid-year budget crisis. Revenues are \$304 million short of what is needed for a balanced budget. By law, this must be corrected before the 2016-17 fiscal year ends on

One plan would cut public education by \$29 million for the first time ever, slashing services to disabled children, Pre-K funding, after school services and more.

It would devastate higher education and health care. **That's not smart!**

Governor John Bel Edwards has a plan that would save education funding by using the state's rainy day fund. Cuts to public services, while painful, would not be as bad.

Some lawmakers oppose the governor's plan, saying the "rainy day fund" should not be tapped. This fund was created specifically for balancing the budget in the event of a deficit.

The Louisiana Federation of Teachers and Jefferson Federation of Teachers supports the governor's balanced, responsible approach to this crisis. Any other response would be an unnecessary hardship on working families and the children attending public schools in Louisiana.

Labor Board Rules that Charter School Teachers Have Bargaining Rights

The National Labor Relations Board ruled that union members in charter schools have the right to collectively bargain with charter operators.

The ruling follows precedents set by NLRB in other cases. It establishes that charter operators, unlike traditional public school boards, are private employers who must, under federal law, negotiate with employees. Traditional school boards are public bodies, and may vote to negotiate with employees if they wish.

Local chapters of the Louisiana Federation of Teachers have negotiated contracts with school boards in St. Tammany and Jefferson Parishes. In New Orleans, the United Teachers of New Orleans have negotiated contracts for educators at Ben Franklin High School and Morris Jeff Community School.
